NOW THIS INDENTURE WITNESSETH - that in order to effectuate their said desire and in consideration of the premises and of various other good causes hereunto moving, the Settlers doth hereby transfer, ~~assign and make over to the Trustees the said sum of~~ Rs.20,000/- (Rupees twenty thousand) only To have AND TO HOLD THE SAME and all additions and accretions thereto and all other sums and properties that may from time to time form part of the TRUST estate (hereinafter referred to as " THE TRUST FUND") unto the Trustees absolutely and for ever upon Trust for public purposes with and subject to the powers, provisions and declarations hereinafter contained of and concerning the same.

5. The Trust hereby established shall be styled as " Gurbachan Singh Trust Estate " (hereinafter referred to as the " Estate") and the Trustee or Trustees for the time being of these presents, may purchase and/or acquire and engage in and carrying out the objects of the Settlers including the establishment and/or running of any educational

Institution under the name and style of "G.S.S. Girls' School etc." for and on account of the said Estate and may invest any part of the funds or assets of the Trust fund in such purposes and objects.

6. The Trustees shall manage the affairs of the Trust hereby established, shall select a place for maintaining the office of the said estate and the office of the said estate shall be situated at 65, Pratapaditya Road, Calcutta 700026 or at such place or places as the trustees may from time to time determine.

7. The objects of the Trust shall be for public Educational purposes with non profit making motive and its income shall be applied or accumulated in India for Public Educational purpose within the meaning of the Income Tax Act, 1961 and any statutory modification thereof and without prejudice to the generality of the aforesaid, the following shall be deemed to be the principal objects :-

- a) To promote, the education of the girls of the Indian Community as well as to the girls of other communities without any reservation of their caste, creed or religion through the medium of the English Language in India.
- b) To establish, support, maintain and grant aid or other financial assistance to Schools, Colleges, Libraries, Reading Rooms, Lecture halls, Dormitories, Hostels and other educational literary, scientific, technical and research institutions in India for the purpose of teaching through the medium of the English language and to render financial assistance to poor and needy students.

c) To hold and manage endowments and to establish bursaries, awards, fellowships, scholarships, studentship, medals and prizes for the Indian children . IT BEING EXPRESSLY DECLARED THAT if any one or more of the objects specified in this clause are held not being object of public, educational nature with non profit making motive as defined by the Income Tax Act 1961 or any statutory modifications thereof, the Trustees shall not carry out such objects but the validity of the Trust created by these presents as Trust for public educational purpose shall not in any way be affected.

B... In the event of the Trustees establishing and or running any Schools, Colleges, Libraries, Hospitals, Nursing Homes, Clinics, dispensaries, Sanatoriums, reading rooms, lecture halls, hostels, dormitories Institutions for handicapped and similar other establishments and institutions, the Trustees shall alone be entitled to form, nominate and constitute the Boards of Management or the Managing Committee or Managing Committees of such establishments and shall be represented in the said Boards of Management, Managing Committee or committees thereof by three or their number, of which the Managing Trustee shall be one, while forming, nominating and constituting the Boards of Management or Managing Committee, the trustees shall take one representative from the parents of the students, one representative from the members of the teaching staff and one member from outside in such Boards or Managing Committees.

D.. Without prejudice to the generality of the powers vested in the Trustees under any law for the time being in force, the Trustees shall have, inter alia, the following powers :-

- a) To accept donations, contributions, grants, and aids subscriptions in cash or in kind from any company, firms, persons or Trust or body for the furtherance of the objects of the Trust.
- b) To apply the whole or part of the income only and not the corpus of the trust fund for one or more of the objects of the Trust as the Trustees may in their discretion from time to time determine.
- c) To convert and deal with the Trust property and /or to vary from time to time the investments for the time being.
- d) To invest and keep invested the Trust fund either in the purchase or mortgage of immovable property/properties, or other Govt. securities and investments and to alter, vary or transpose such investments from time to time as the Trustees shall in their discretion think fit.
- e) To borrow or raise loan from any Nationalised Bank or Institution or Institutions or financial institution or organisation or to borrow or raise or secure payment of money and also to lend money with or without security.
- f) To sell, dispose off alienate or otherwise deal with any Trust property movable or immovable as may be deemed fit by the prevailing circumstances.
- g) To let out and demise any immovable property, comprised in the Trust for such period, at such rent and on such terms and conditions as the Trustees in their absolute discretion shall think fit .

h) To open Bank Account or Accounts with any Nationalised Bank or Banks and to operate the same account and to give instruction to the Bank and to provide for opening and operation of such account by one or two of the Trustees authorized by the Board of Trustees provided however that the Managing Trustee shall be eligible to operate the Bank account singly. In case the Managing Trustee dies or leaves or resigns, then the person concern in clause 14 will take over the charge of running the Bank account, and any other institution as mentioned above of the Trust. In case of death of S. Probjot Singh or his ceasing to be the Managing Trustee/Secretary then Mrs. Ranjit Kaur will be appointed unanimously as the Managing Trustee/Secretary/Treasurer of the Trust in order of the protocol as per clause 14 of the Trust Deed.

i) To adjust, settle, compromise, compound and refer to arbitration all actions, suits, claims, demands and proceedings relating to the trust and to demand and sue or to commence, prosecute or enforce or to defend, answer or to oppose all action or proceedings if any of the matters relating to the administration of the trust and for such purpose to authorise any of the trustees to sign and verify pleadings, to sign Vakalatnams and to offer in Court and to all prosecution and/or to defend any legal action or actions.

j) To appoint Co. Trustees or any other person as constituted attorney or agent or manager and to delegate to such attorney or agent or manager all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents or managers and to

- k) To make, vary alter or modify schemes, rules, and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and for running any institution in furtherance of the objects of the trust and otherwise for giving effect to the objects of the Trust.
- l) To appoint professors, teachers, lecturers, instructors, officers, clerks, durwans and servants on permanent or temporary basis as they may from time to time think fit and to determine their powers and duties and to fix their salaries or emoluments (if any) and to suspend, remove or to dismiss any of them as the occasion may arise,
- m) To constitute or provide for the constitution of boards of management or Managing Committee for the trust's schools and other educational establishments and institutions and to make rules and regulations for the working thereof with due regard to the relevant Government regulations.
- h) To start, abolish, discontinue and re-start any educational establishments and institutions and to impose any conditions for and in respect of any subscription or donation made by donors.
- o) In the event of any property belonging to the trust being acquired or requisitioned, to get the compensation or ~~the~~ statutory allowance payable for such acquisition or requisition

- p) To take all legal actions, that may be required in course of the management of the trust and to delegate such powers and authorities from time to time as may be necessary to any person or bodies for the purpose.
- g) To open, run & continue an educational and vocational School or institution meant for the public purpose under the name and style of "O.S.S. Girls School etc." to delegate such powers, authorities and discretion herein before mentioned as the Trustee may deem fit and proper from time to time to any committee or committees for managing the affairs of the said School. Provided however that such a committee shall consist of the Trustee or some of the Trustees for the time being together with any other person or persons not being a Trustee, whom the Trustee or Trustees may select and that the Trustee or Trustees may at any time revoke either wholly or partly the authority so/^{conferred} ~~conferred~~ on any such committee from time to time as the Trustee or Trustees may deem fit and expedient.

10. Trustees Responsibilities :-

The Trustees shall be respectively accountable / answerable only for such moneys, stock, funds, Govt. Securities or property as they shall respectively actually receive, ~~not withstanding~~ their signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts, receipts, neglect or defaults and not for those of each others.

11. Receipts granted by persons authorised by the trustees by a resolution of the Board of Trustees for any money paid or any property transferred or delivered to the Trustees in the execution of any of the trusts or powers hereof or for the purchase of any property authorised or to be sold shall effectually discharge any persons so paying or transferring or delivering any property.

12. The Trustees shall maintain true and fair accounts to be kept of all money receive and spent and of all matters in respect thereof in ~~course~~ of management of trust estate or in relation to the carrying out of the objects and purposes of the trust as well as of all the assets, credits and effects of the trust estate and shall adjust the same, every year ending with the 31st day of March, and shall get the same audited.

13. The Trustees will not be entitled to receive any remuneration but the Trustees may reimburse themselves of all expenses actually incurred by them in connection with the trust or their duties relating thereto. Any member of the Board of Trustees shall not have any personal claim over the property of the Trust nor their heirs shall have any claim over the property of the Trust.

14. The Trustees shall be from Sikh minority community and shall not be less than three and more than nine.

15. Sardar Tajinder Singh Soni, will be the Chairman

of the Board of Trustees during his life time and shall preside at all meetings of the Trustees with such powers as may from time to time be delegated to him. If the Chairman is unable to attend at any meeting of the Board of Trustees then in that event the Managing Trustee shall preside and in his absence the remaining trustees or a majority of their numbers shall elect one of them to act as Chairman of that meeting.

16. Sarder Probjot Singh will be the managing Trustee cum Secretary of the Board of Trustees during his life time. He shall be vested with all powers and authorities in the matter of the Trust hereby created which the Board of Trustees or the Trustees in majority can exercise and shall be competent to do executive perform all acts, deed, matters and things including operating singly of the Banking Account of the Trust or any other institutions run by the Trust, which the Board of Trustees or the Trustees in majority can do or execute and perform. Smt. Ranjit Kaur shall act as Joint Secretary cum Treasurer in order of protocol of the Trust. In case of death of S. Probjot Singh or his ceasing to be a Managing and executive Trustee cum Secretary due to unforeseen circumstances, then Smt. Ranjit Kaur will be the Managing and Executive Trustee cum Secretary cum Treasurer in order of protocol and will take on all the powers and duties of the Managing and Executive Trustee cum Secretary cum Treasurer as mentioned above during her life time.

17. The Board of Trustees shall have at least two meetings in a year to decide from time to time as to the mode and procedure of carrying out the purposes of the Trust. The Chairman

shall serve or cause to be served notices of all such meetings to the Trustees at least seven days before the date of the meeting.

18. Any two Trustees shall form a quorum for any meeting of the Trustees. A meeting of the Trustees at which a quorum is present shall be entitled to exercise all or any of the powers vested in the Trustees under these presents or in law.

19. All questions arising in the management and administration of the trust and its properties and differences of opinion among trustees, if any, shall be disposed of in accordance with the opinion of the Managing Trustee and with his direction and after his death or ceasing to be trustee, all question, arising out in the management and administration of trust shall be disposed of in accordance with the opinion of the majority of Trustees and in case of equal division, The Chairman shall have a casting vote.

20. A resolution in writing circulated amongst all the trustees and signed and agreed to by majority of the trustees shall be as valid and effectual as if it had been passed at a meeting of Trustees duly called and convened.

21. All meetings of the Trustees, shall be held generally at the Registered office of the Trust or at such..

22. A Trustee who is unable to be present at a meeting of the Trustees, may send his or her views on the Agenda in writing and such expression of opinion, shall be taken, to be his or her vote on the matter concerned.

23. The minutes of the proceedings of every meeting of the trustees, shall be entered in a book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting, when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.

24. The trustees shall be entitled to frame rules, add to, vary and/or alter them from time to time as circumstances may require for regulating their meetings or otherwise not, as it may appear fit and proper.

25. No person being :-

- a) An undischarged insolvent or
- b) Convicted of an offence involving moral turpitude or
- c) Unsound mind, or
- d) A minor shall not be eligible to be a Trustee.

26. A person will cease to be a trustee in any of the following events :-

- a) If he or she dies, or
- b) If he or she becomes bankrupt, or
- c) If he or she becomes insane or otherwise becomes incapable to act, or
- d) If he or she resigns by giving one calendar month's notice in writing to the other Trustees of his or her intention to do so,
- e) If he or she remains absent for three consecutive meetings.
- f) If he or she is requested to resign by all the remaining Trustees.
- g) If his/her activities are proved to be detrimental to the interest of the Trusts and its units .

27. It shall be lawful for the Board of Trustees from time to time to select new trustees with an unanimous decision in addition to the Trustees for the time being or in place of any Trustee or Trustees who shall die or emigrate out of India for more than 6 months or shall desire to retire from and/or refuse or become unfit or incapable to act in the trust but so that the total number of trustees shall not be less than three and more than nine. In the event of the death of the Managing Trustees it shall be lawful for the surviving trustees or continuing trustees

to fill the vacancy subject to the condition stated in clause 14 created due to death, retirement or refusal and/or any incapability or part of any of the trustee/trustees. Trust properties shall always vest in the trustees and upon every appointment made under the terms, herein the same shall vest and/or be transferred to the New Board of Trustees.

28. The Managing Trustee would also be given the additional responsibility of acting as a Secretary of the Managing or the Governing Body of the G.S.S.Girls' School etc. during his life time, but after his death or ceasing to retain the office of the Secretary-ship of the Managing/or the Governing Body of the School Committee, the honourable members of the school committee, would have a right to appoint a New Secretary, as stated in clause 14⁵ unanimously.

29. With the approval from the Board of Trustees, a Trustee or Trustees could be appointed to the post of President, Vice-President/Treasurer, Manager/General Secretary, Principal, Headmistress and members of the Managing or the Governing Body of the G.S.S.Girls School etc. The first

first managing committee of G.S.S. Girls' School etc. would be appointed or selected or nominated by the Executive Board of Trustees. The Board of Trustees have full power to take decision regarding the remuneration, medical benefit and to provide official car cum transport facilities to the individual executive member of the Board of the Trustees and to the Principal, Headmistress, Secretary and to teaching staff if they deem fit along with the above the Board of Trustees.

30. With consent of all the trustees for the time being of the trust, the trustees shall be entitled to add to the objects of the trust subject to the condition that any such addition shall be confined solely to public educational purpose within the meaning of the Income Tax Act 1961 and any other statutory modification thereof any by a majority of two thirds of all the trustees present at the time and to add or alter the rules and regulations herein mentioned.

31. The board of Trustees of the Trust shall have full right to get the resignation from any member of the managing/Governing body of the G.S.S. Girls School if :-

a) He/She is found guilty in Court of law & the offence is also found against the objectives & concepts of the Trust.

- b) He/she is found indulging in such activities which directly or indirectly harm the Trust in prestige, working or cause harm to the property or School discipline.
- c) He/She is found doing mischievous activities or mal-practices, which may defame the Trust because of one's association with the Trust.
- d) If in the opinion of the Board of Trustees one is for the purpose of the Trust.

32. The Trustee or Trustees for the time being of "Gurbachan Singh Trust Estate", shall be jointly at liberty to amalgamate with any other Trust or to make over and transfer to any other Trust, Society Body or institution having objects similar to those mentioned herein the Trust fund or such part or parts thereof as shall for the time being or the investments for the time being representing the same upon and subject to the terms and conditions that the same or the income thereof shall be spent and applied for all or any of the objects aforesaid or for carrying into effect all or any of the trusts aforesaid.
